**RESOLUTION NO. 15**

**MEMORIAL RECOGNITION FOR CARL D. SHOEMAKER**

WHEREAS, Carl David Shoemaker worked for the preservation and wise management of America's wildlife resources for more than half a century beginning as Director of the Oregon State Game Commission and continuing for 13 years, and served subsequently as Secretary of the Special U. S. Senate Committee on Conservation of Wildlife Resources, and as first Executive Officer helped to establish the National Wildlife Federation;

WHEREAS, he played a key role and was one of the pioneers for conservation information of the American Game Conference, in the development of the so-called "Model Law", the distribution of information on Congressional wildlife legislation and development of the Duck Stamp, Pittman-Robertson and Wildlife Coordination Acts; and

WHEREAS, Carl Shoemaker, receiver of the Aldo Leopold Award and the Distinguished Conservation Service Award of the Wildlife Management Institute, one of the six Honorary Life Members of the International Association of Game, Fish and Conservation Commissions and Honorary President of the National Wildlife Federation, passed on to his reward early this year:

NOW, THEREFORE, BE IT RESOLVED, that the International Association of Game, Fish and Conservation Commissioners honors Carl David Shoemaker and his lifetime of work for conservation with this memorial resolution; and

BE IT FURTHER RESOLVED, that a copy of this resolution shall be duly certified by the Secretary and by him transmitted to the family of Carl David Shoemaker.

**RESOLUTION NO. 16**

**MEMORIAL RECOGNITION FOR NICHOLAS V. OLDS**

WHEREAS, Nicholas V. Olds died on the 7th day of August, 1969; and

WHEREAS, he served the cause of conservation for many years as head of the Michigan Attorney General's Natural Resources Division, where he marshalled the State's legal attack against the diversion of Lake Michigan waters by the State of Illinois and mapped the legal strategy in many vital cases relating to water pollution and the preservation of Michigan's streams and waterways; and

WHEREAS, he served ably and with distinction as longtime Chairman of the Association's Legal Committee during a critical period in the struggle for preservation of clean waters and undisturbed wildlife habitat, federal and state controversies over jurisdiction of resident fish and wildlife, and other problems affecting the welfare of sportsmen and non-sportsmen;

NOW, THEREFORE, BE IT RESOLVED, by the International Association of Game, Fish and Conservation Commissioners, that in the passing of Nick Olds, the Association has lost an able and dedicated member, and an outstanding citizen whose devotion to the cause of conservation was expressed in a lifetime of public service; and

BE IT FURTHER RESOLVED, that a copy of this Resolution shall be duly certified by the Secretary and by him transmitted to the family of Nicholas V. Olds.
