passage of this bill is absolutely essential to the effective administration of the existing federal game laws and the maintenance of migratory birds on the North American continent.

The association therefore urges that the bill be passed before the adjournment of the present session of congress.

It was voted unanimously to adopt the following resolution:

Resolved, That the sincere appreciation of the members of the International Association of Game, Fish and Conservation Commissioners in convention assembled be expressed to the mayor of this beautiful city Madison and to the officers of the Wisconsin Commission of Conservation for their cordial welcome, the privilege of using these spacious quarters in the capitol and the interesting and instructive exhibits and excursions to the hatcheries and the Dells.

It was voted unanimously to incorporate the following memorial, presented by Mr. I. T. Quinn, of Alabama, in to the records:

Mr. President, as the successor to the late John H. Wallace, Jr., of Alabama, I should like to state that his untimely departure from the common walks of men was a serious shock and an irreparable loss to all the people of Alabama, to the conservationists of his native state, and to the nation. John Wallace was inherently a lover of the beautiful and the useful in nature. His entire life was spent in advocating those principals which tend to protect, conserve and develop the natural resources of his state and the wild life of this nation. He was truly an apostle of conservation, a minister to the needs of his state and nation, and a counsellor and adviser to more state legislatures and organizations than perhaps any other man of his day. The state of Alabama mourns his death.
