RESOLVED, That the International Association of Fish, Game, and Conservation Commissioners is uncompromisingly opposed to any action on the part of the federal government of the United States that would in or wild life of the various national parks, and that the secretary of this association be authorized and instructed to be vigilant in watching for such attempts and in case occasion arise shall at once file strong protests in our behalf with the proper authorities. ✓ ↑

WHEREAS, Co-operation between Canada and the United States is a fundamental necessity for the proper development of the joint conservation interests of the two countries, including the fish and fish interests within any way violate the sanctity of the boundaries of the lakes, rivers, forests international waters, be it

RESOLVED, First, that this association urge upon congress the necessity of ratifying the bill now before that body entitled, "Treaty for the Protection and Development of the Sockeye Salmon of the Puget Sound and Fraser River"; and be it further

RESOLVED, That the president of this association be empowered and he is hereby requested to appoint a committee to consist of a citizen of each country, who is also a member of this association, that such committee shall confer with the proper authorities in the two countries to the end that necessary steps may be taken to put into effect existing means of bringing about these objects, or if existing means are judged to be inadequate, to urge the development of a basis of agreement upon which conservation of our great joint natural resources may be obtained.

RESOLVED, Word having been received that our fellow member, Hon. Joseph G. Sachs, general counsel to the association, has passed away; be it

RESOLVED, That the secretary be instructed to write a fitting resolution to be engrossed on the records of the association and that a copy of these resolutions be furnished to the family of the deceased.

RESOLVED, That the International Association of Fish, Game, and Conservation Commissioners in annual convention assembled desire to express to the government of Canada, its sincere appreciation for the many courtesies extended which have made this convention exceedingly enjoyable and very successful, and in particular, to the Hon.
